Mace Memorial Board of Education Scholarship Fund (up to 12 meetings) for Board member terms beginning January 1, 2024.
- Set compensation at \$125.00 per meeting for up to 13 board meetings per year 12 regular and/or special meetings, the 13th shall be the All-County Board of Education meeting, with \$67.00 per month, per member set aside for the David W. Mace Memorial Board of Education Scholarship Fund (up to 12 meetings) for Board member terms beginning January 1, 2026.
